

Privacy Policy

This privacy policy discloses the privacy practices for www.kpm-eu.com and applies solely to information collected by this website.

You do not need to give us any personal information to use most of this site. However, if you would like to benefit from certain special services, you will need to provide us with some information. It is important to KPM (UK) that you are reassured that the information which you provide to us is used fairly and held securely. This notice explains our online information practices and the way your information is used on this site.

We do not collect personally identifiable information about you- such as your name, address, telephone number, fax number, email address etc unless you choose to submit your details in one of the following areas of the site or email us directly:

- Feedback form
- Register with KPM (UK) Distributor Zone
- Career Opportunities
- Submit Your CV

We do automatically collect certain non-personally identifiable information when you visit our site, such as the type of browser you are using, the type of operating system you are using and the domain name of your internet service provider.

We use information held about you in the following ways:

- Marketing KPM (UK) products and services
- Improving KPM (UK) products and services
- Market research and statistical analysis
- Assessing your application for sponsorship/employment

If you are an existing customer, we will only contact you by electronic means with information about goods and services similar to those which were the subject of a previous sale to you.

If you are a new customer, we will contact you by electronic means only if you have consented to this via the online enquiry form.

We may also pass your information to other members or associates of the Kawasaki Heavy Industries group of companies and their dealers but we will not pass this information to any organisation outside of this group. You acknowledge and agree that your information may be transferred to our offices operating in countries outside the EEA. We will use our reasonable efforts to maintain the security of your information, but we cannot guarantee the privacy of personal information you transmit over the web or that may be collectable in transit by others, including contractors who provide services to us.

By using our site, you consent to our storage and use of your information for the purposes set out above.

Our site contains links to other sites whose information practices may be different than ours. Visitors should consult the other sites' privacy notices as we have no control over information that is submitted to, or collected by, these third parties.

When you visit our website we send you a cookie. A cookie is a text-only string of information that a website transfers to the cookie file of the browser on your computer's hard disk so that the website can remember who you are.
